10. That the school shall submit the latest copy in r/o maintenance of DRF account within 02 months to the district authority.
11. That the school shall comply with clause 14 of order No. F.DE/15 (56)/ACT/2009778 dated 11.02.2009 in r/o maintenance of DRF. School also ensures to follow FN-21 'Accounting by school' as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
12. That the school shall make payment of salary and other admissible allowances to its teaching/non-teaching staff as per ongoing CPC through bank/RTGS.


